Leadership Team Report

What a year of change!

We started the year in a provincial lockdown with pre-recorded audio and video worship services and minimal use of our facilities. As provincial COVID regulations lifted, we followed Huron-Perth public health guidelines and gradually removed our COVID protocols. This enabled resumption of in-person worship services including the choir and Sunday School, social gatherings, and increased facilities use by groups in our community.

Our church facilities were used by many groups: South Huron Community Choir, Alcoholics Anonymous, Narcotics Anonymous, Alanon, Supervised Access, Exeter Friendship Group, Healthy Lifestyles, Big Brothers Big Sisters, and the Huron County Christmas Bureau. The sanctuary was used for fall concerts performed by the South Huron Community Choir and the Toronto Gospel Choir.

In April, we approved our church building becoming the home for the new South Huron Arts Centre with it being an outreach project for its first 12 months of operation. Approved minor facilities renovations were completed and a grand opening was held on September 24. A successful fall program ran from September to December with winter and spring programs scheduled to run from January to June 2023.

In the spring, planning was initiated for two approved capital projects - replacement of the James St. doors and installation of a new universal washroom. These projects are required to enable our facilities to be used in the future – by us and the community groups who use our building.

In the summer, a small team of volunteers completed clean-up of basement rooms and storage areas.

With Rev. Laurie O'Leary's departure in September, pulpit supply was used for the remainder of the year's worship services. We enjoyed worship leadership from David Burghardt, Kate Monk, Paul Vollick, and Heather MacKecknie.

In the fall, our Ministry & Personnel (M&P) Team initiated work to update our Community of Faith profile. This is the first step in the process to confirm what we need before we can move forward to search for a new minister.

Due to poor weather conditions, the year ended with the cancellation of our in-person Christmas Eve service. Thanks to the generosity of Rev. Nancy Knowles, the video version of Thamesview United Church's Christmas Eve service was made available to our congregation.

Thank you to everyone whose donation of treasure (money), time and talents helped to keep our church operating.

As a Leadership Team, we appreciate the support received in 2022 and ask for continued support as we confirm our needs and move forward with necessary changes.

Finance and Stewardship Team Report

The general operating budget was monitored at a detailed level throughout all of 2022. Due to the uncertainties of the year, future month's income and expenses we re-estimated to forecast year-end results. Summary level financial reporting was produced and reviewed monthly at Leadership Team meetings.

A bequest of \$20,000.00 was received from the estate of Anne Bell, in memory of the Elmer Bell family. Most of this bequest was used to eliminate the gap between income and expenses with the balance used for 2022 capital project expenses.

No stewardship activities were completed.

Ministry and Personnel Team Report

After the retirement of Joan Kammerer in April 2022, the M&P committee chair for the past 4 years, and then Rick Hundey leaving, I became the committee and the chairperson. Cheryl Masson and Janice Brock immediately stepped up to help.

In late summer and early fall, following the retirement of Rev. Laurie, our team called or talked to over 50 households. We asked our congregation for ideas and advice on how best to go forward as we look to the future ministry. There was no doubt in our committee after these calls that EUC has to change to accommodate the aging demographics and smaller congregation.

In November, Cheryl and Janice addressed the congregation each at different times. Cheryl talked about change because if we maintain things as they have been, we will probably be looking at closure some time down the road. If we want EUC to continue well into the future, what changes might we need to take? Janice informed the congregation on the concept of sharing or collaboration with other congregations. She said our current situation is not unique and that many local churches are also assessing their needs.

In December, Lois told the Ladies Coffee and Conversation Group that we have so much to be thankful for at EUC. We have a great facility, good staff and a committed Leadership Team. We have many providers and organizers of Bake Sales, Church Decorations, Sunday School Programs. As well we have varied pulpit supply, coffee and conversation social times and much sharing of appreciated musical talent.

Also in December, we approached Pastor Paul Vollick who had been acting as our Pastoral Liaison from Regional to come into a working arrangement with EUC. This is to help us through what we now realized will be a much more lengthy process than previously anticipated. As a result of this, in January 2023, Pastor Paul has become a quarter part time supply minister and will provide pastoral care support to our congregation, help us through our process and preach two Sunday services a month. This is a six month appointment with an option to renew up to 18 months.

Much discussion has taken place and our committee welcomes more feedback as we go through this journey together.

On behalf of the congregation and the M&P Committee I would like to express thanks to all of our staff here at EUC for their commitment in keeping our church functioning day to day: Laurie Johnston our Office Administrator, Lynn Alderdice our Treasurer, Anne Lindenfield for Cleaning Services, Lana Shapton and Doug Klopp our talented musicians and although not on staff, Rob Robillard for his leadership to the Choir.

Sunday School Report

Due to the pandemic, we have not been holding weekly Sunday school since 2020 but began outdoor activities once a month beginning April 3, 2022 when we rented the ice and had our traditional skating party which was enjoyed by many families. Sunday, June 5 we enjoyed a Scavenger Hunt at Morrison Dam led by Barb and Jillian and we were pleased by the number of families that participated after being away for so long.

The Sunday school team decided to not begin regular classes in September until the children had been back in school a couple of weeks and to share via email what Sundays we would be teaching at EUC or holding outdoor events. We started Sunday school September 18 and our focus was Heroes of the Bible for the coming session beginning with Noah. On September 25 we met at Morrison Dam for our yearly walk on the trail. During Thanksgiving we provided activity sheets upstairs for the children to enjoy. On October 16 we had in class lessons and on October 23 the children helped flip pancakes and set up for the Pancake and Sausage breakfast sponsored by the Outreach Committee. October 30 we were thrilled to have Mercedes and Bev Prout volunteer to host a Super Hero All Saints Day celebration at their farm. The children participated in themed games and searched for and put together a puzzle that Mercedes created. Themed snacks were also gobbled down by our superheroes. It was a "Super" Sunday! Many thanks to Mercedes and Bev for all their preparation and hosting. More food preparation was learned and shared for the Sunday school Hot Dog Lunch which was organized to complete our fundraising for Operation Smile which was started in March 2020. Approximately 6 smiles were purchased at \$240 a smile, thanks to our very generous church family!

We also decided to offer Sunday school every Sunday during November and December except when the church is closed for Christmas. We held a December skating party and baked our delicious shortbread cookies.

The musical talents of Molly and Hazel Groot were shared during Advent season. Thank you ladies for sharing your gifts. We would also like to thank Joanne Bowen and Rev. Laurie for all the bags of fun that were delivered to the Sunday school families and friends over the past two years. It was greatly appreciated and enjoyed by the children, especially the treats! Lastly thanks to you, our church family for supporting the children and helping them grow in the spirit of love, faith, and kindness.

Property Team Report

The past year the property committee has been busy developing a plan for the installation of a universal washroom. Provincial mandated handicap accessible washroom laws have been pushed out and are now scheduled to come into effect in 2025. Allan Avis Architects has delivered plans to convert the existing janitor/ storage room into universal accessible washroom as well as update the existing washrooms. A new janitor's closet will also be created next to the basement stairs beside the new washroom. Costs are coming in at around \$200,000 and we may modify or break

up some to help bring the costs down. Input from the congregation meeting is being. Both sets of external doors on James St. need to be replaced due to damaged hinges and misaligned frames. The Property Team is proceeding with the replacement contracting for the work to be done by W. H. Smith Construction. The estimated cost for this replacement is \$25,000. A big thank you goes to Don McCaffery for his input and work during the past year. And the volunteers who have helped keep our building and property looking presentable.
